LOCATION

The subject property is located towards the top end of Castle Street in Hinckley, which is the main retail thoroughfare in the town. The Britannia Shopping Centre is circa 100m from the property, featuring occupiers including New Look, Greggs, Peacocks and Boots. Nearby occupiers include MCC Hobby Centre, LOROS, AgeUK, Swinfen butchers and Kennedy's hairdressers.

Hinckley is a market town with a population in the order of 55,000 (Local Authority 112,000) lying approximately 13 miles to the south west of Leicester. The town enjoys good motorway communications with Junction 1 of the M69 Motorway, being located on the south eastern fringe of the conurbation approximately 2 miles from the town centre. Hinckley railway station provides regular commuter services to Birmingham New Street and Leicester.

DESCRIPTION

The subject property comprises retail premises in a prominent position on Castle Street in Hinckley town centre, benefitting from a small return frontage to Castle Street and ancillary accommodation above.


